Prodigy Cup^{TM} Prodigy State ChallengeTM, Prodigy National Cup^{TM} and Prodigy Spark Cup^{TM} Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS COMPETITION

1. General Information: The Prodigy CupTM includes the Prodigy State ChallengeTM, Prodigy National CupTM and Prodigy Spark CupTM (the "Competition"), sponsored by Prodigy Education Inc. ("Prodigy"), is a series of monthly competitions (each a "Monthly Competition"), the Prodigy National CupTM competitions ("Prodigy National CupTM Competitions") and the Prodigy Spark CupTM competition ("Prodigy Spark CupTM Competition") and begins at 1:59 a.m. Eastern Standard Time on September 15, 2025 and ends at 2:59 a.m. Eastern Daylight Time on May 15, 2026 (the "Competition Period"). Results of the Monthly Competitions determine qualification for the Prodigy National CupTM Competitions or participation in the Prodigy Spark CupTM Competition. The Monthly Competition periods are:

September 15, 2025 - September 30, 2025; October 1, 2025 - October 31, 2025 November 1, 2025 - November 30, 2025 December 1, 2025 - December 31, 2025 January 1, 2026 - January 31, 2026 February 1, 2026 - February 28, 2026 March 1, 2026 - March 31, 2026 April 1, 2026 - April 30 2026 (each a "Monthly Competition Period")

Eligible schools from the Monthly Competition Periods will qualify for the Prodigy National CupTM Competitions which take place from May 1, 2026 through May 15, 2026 (the "**Prodigy National CupTM Competition Period**"). Schools that do not qualify for any Prodigy National CupTM Competition can compete in the Prodigy Spark CupTM Competition from May 1, 2026 through May 15, 2026 (the "**Prodigy Spark CupTM Competition Period**").

No purchase is necessary to enter or win, and purchase does not improve odds of winning. The Competition is void wherever prohibited by law, or where the Competition does not comply with applicable registration or filing requirements of any state or local jurisdiction. By entering the Competition, you agree to these Official Rules, which are a contract, so read them carefully before entering. This contract includes limitations of your rights and remedies.

- 2. **Participation and Tiering:** Schools can participate ("**Participation**") by having students in their elementary school classes located in the United States (Grades 1-8) ("**Student Participants**") answer math questions in Prodigy Math Game. Any Participation must:
 - comply with these Official Rules in all respects;
 - not contain material that is offensive, defamatory, threatening, abusive, vulgar, sexist, discriminatory or otherwise inappropriate;
 - not promote or incite violent, dangerous or antisocial behavior;
 - not violate the terms of any employment, work for hire, or any other agreement; and
 - not in any other way violate any applicable law, rule, regulation, guideline or community standard (collectively, the "Participation Requirements").

Schools will be grouped into Tiers (Small/Heroic, Medium/Mythical and Large/Titan) for the Competition based on school enrollment. Tiering is based on the number of active students in the United States in grades 1-8 recorded by Prodigy and/or on publicly available NCES enrollment data and/or enrollment verification by an eligible school that is acceptable to Prodigy. Each eligible school will be placed into the corresponding Tier by Prodigy. Once a school is placed in a Tier by Prodigy, it will remain in that Tier for the duration of the Competition unless a Tier change is mandated by Prodigy. All determinations made by Prodigy of a school's

Tier for the Competition are final. Schools that qualify for a Prodigy National Cup[™] Competition will qualify in the same Tier as their Tier for Prodigy State Challenge[™] Monthly Competitions. Tiers are as follows:

Large/Titan	600+

3. **How to Enter:** Schools that meet the Eligibility requirements in Section 4 are entered into a Monthly Competition when Student Participants in their grade 1-8 elementary school classes that are attached to the school correctly answer questions in Prodigy Math Game during any Monthly Competition Period. A teacher can attach their class to their school in the teacher application in Prodigy Math Game. Eligible Competitors can follow their progress in the Monthly Competition Periods by viewing the leaderboards for their State and Tier. Only correctly answered questions count towards an Eligible Competitor's total number of questions answered.

Qualification for the Prodigy National Cup

Eligible Competitors that finish in the Top 5 in a Monthly Competition Period will automatically be qualified for the Prodigy National CupTM Competition in their Tier without the need to compete in any additional Monthly Competition Period ("Prodigy National CupTM Qualifiers"). NOTE: The Eligible Competitor that finishes 1st in each Monthly Competition Period is no longer eligible to compete in subsequent Monthly Competition Periods. The Prodigy National CupTM Competition in each Tier will consist of Prodigy National CupTM Qualifiers in the Tier from all States.

Prodigy Spark Cup

Eligible Competitors that are not Prodigy National CupTM Qualifiers will qualify for a separate competition called the "Prodigy Spark CupTM" which will take place during the Prodigy National CupTM Competition Period ("**Prodigy Spark CupTM Qualifiers**"). Prodigy Spark CupTM Qualifiers from all States will compete against each other (regardless of their Tier during the Monthly Competition Periods) for the Prodigy Spark CupTM.

4. Eligibility: The Competition is open only to schools formally recognized and approved under state or a local education authority with grade 1-8 classes using Prodigy Math Game with classes attached to the school and located in the 50 United States and the District of Columbia (each a "State") (NOTE: Maryland and District of Columbia are grouped together as a "State" for the purposes of the Competition), subject to all applicable federal, state and local laws and regulations ("Eligible Competitors"). For clarity, home schools or parent-directed education programs are not Eligible Competitors. Schools that have at least one grade 1-8 class that is attached to the school that has, in a Monthly Competition Period used Prodigy Math Game and answered at least one (1) question correctly, are automatically opted into that Monthly Competition Period and become Eligible Competitors. Teachers and/or schools who wish to opt out of participating in the Competition can do so by clicking "Opt out of State Challenge" in the teacher application in Prodigy Math Game.

The Competition is not open to (a) any employees of Prodigy or any of the respective parent companies, subsidiaries, affiliates, or advertising or promotion agencies of any of the foregoing (such entities, collectively, the "Promotion Parties"), or (b) any such employee's immediate family members (e.g., spouse, parent, step-parent, sibling, step-sibling, half-sibling, child, and step-child) or any person living in the same household as such individuals. Any false or deceptive entries or acts associated with an Eligible Competitor (including, but not limited to, if applicable, creating or using multiple accounts in order to enter multiple times, having persons other than Eligible Competitors and/or Student Participants (e.g., teachers or parents) submit answers, stacking of assignments (e.g., repetition of below grade content assigned to

students for the purpose of lowering question difficulty to inflate number of questions answered) or similar manipulation) ("Irregularities") may result in those answers being deducted from the school's total number of correctly answered questions and/or classrooms or schools being declared ineligible to participate in subsequent Monthly Competitions or Prodigy National CupTM. Any use of robotic, automatic, programmed or similar methods of entry, or stacking of assignments by a teacher, school or a student at a school may disqualify that school from the Competition or render the questions answered ineligible for inclusion in the score for that school. Prodigy will adjudicate Irregularities and determine adjustments to total questions answered or changes to future eligibility on a case-by-case basis in its sole discretion. All decisions by Prodigy with respect to Irregularities or total questions answered will be final.

5. **Winner Selection and Notification:** Prodigy may disqualify any entry which it deems not in compliance with these Official Rules.

Prodigy State ChallengeTM Monthly Competitions

During the Monthly Competitions, Eligible Competitors will compete against other Eligible Competitors in the same Tier in their State for the prizes described in Section 6. Eligible Competitors will be ranked within each Tier based on the number of eligible correct answers submitted via Prodigy Math Game during a Monthly Competition Period. At the end of each Monthly Competition Period, Prodigy will determine the number of correct answers each Eligible Competitor has submitted during the respective Monthly Competition Period. Prodigy will award Monthly Competition Prizes to Eligible Competitors as described in Section 6, based on the Eligible Competitors in their Tier in their State for the given Monthly Competition Period as determined by the total number of correct answers submitted by the Eligible Competitor in the Monthly Competition Period. Each Monthly Competition Period will be ranked separately and neither rankings nor answers from a prior Monthly Competition Period will carry over to a subsequent month. The winner(s) of each Monthly Competition will be declared within seven (7) business days after the end of each Monthly Competition Period and winners will be notified (the "**Prodigy State Challenge**TM **Winner Notifications**") by email, using contact information from the winner's Prodigy account or provided at the time of entry.

Prodigy National CupTM

During the Prodigy National CupTM Competition Period, Eligible Competitors who are Prodigy National CupTM Qualifiers will compete against other Eligible Competitors who are Prodigy National CupTM Qualifiers in the same Tier nationally for prizes described in Section 6. Schools will be ranked within each Tier based on the number of eligible correct answers submitted via the Prodigy Math Game for each participating school during the Prodigy National CupTM Competition Period.

The winner(s) of the Prodigy National CupTM in each Tier and prizes will be declared within five (5) business days after the end of the Prodigy National CupTM Competition Period. Each winner will be notified (the "**Prodigy National CupTM Winner Notification**") by email, within approximately five (5) business days after the winner(s) have been selected, using contact information from the winner's Prodigy account or provided at the time of entry.

Prodigy Spark CupTM

During the Prodigy Spark CupTM Competition Period, Eligible Competitors who are not Prodigy National CupTM Qualifiers will compete against other Eligible Competitors who are not Prodigy National CupTM Qualifiers nationally for prizes described in Section 6. Schools will be ranked in the Prodigy Spark CupTM Competition based on the number of eligible correct answers submitted via the Prodigy Math Game for each participating school during the Prodigy Spark CupTM Competition.

The winner(s) of the Prodigy Spark CupTM and prizes will be declared within five (5) business days after the end of the Prodigy Spark CupTM Competition Period. Each winner will be notified (the "**Prodigy Spark CupTM Winner Notification**") by email, within approximately five (5) days after the winner(s) have been selected, using contact information from the winner's Prodigy account or provided at the time of entry.

If, for any reason, (a) more than one *bona fide* winner comes forward seeking to claim a prize or (b) there is a tie, then, in Prodigy's sole discretion, (i) the applicable prize may be awarded to each such *bona fide* winner or person who submitted a tying Submission, or (ii) a single winner will be selected in accordance with the above criteria and winner selection process from among such *bona fide* winners. Each winner will be required to (A) respond to the Winner Notification (as directed in the Winner Notification) within three (3) days after its transmission and (B) complete, sign, have notarized, and postmark an Affidavit of Eligibility and Liability and Publicity Release (where not prohibited by law and if requested by Prodigy) within five (5) business days of its delivery to the winner. Milestone Rewards for Student Participants

Student Participants at Eligible Competitors may also receive digital rewards in Prodigy Math Game based on the Eligible Competitor reaching milestones for the number of questions answered during the Monthly Competitions (the "Milestone Checkpoints"). Student Participants who have answered at least 1 question during the Monthly Competition Period are eligible to receive the digital reward when an Eligible Competitor reaches a Milestone Checkpoint. Digital rewards will be awarded to eligible Student Participants at Eligible Competitors at the following Milestone Checkpoints (total number of questions answered by the Eligible Competitor during the Monthly Competition Period): 500, 1,000, 2,500, 5,000, 10,000, 15,000, 25,000, 100,000, 150,000, 200,000, 300,000, 400,000 and 500,000. An Eligible Competitor's progress towards Milestone Checkpoints resets for each Monthly Competition Period.

- 7. General Prize Terms: The ARV of the prize(s) is based on information available to Prodigy. Prodigy is not responsible for, and a winner will not receive the difference (if any) between, the actual value of the prize(s) at the time of the award and the stated ARV in these Official Rules. A single, neutral arbitrator will resolve Claims. The arbitrator will be either a lawyer with at least ten (10) years' experience or a retired or former judge, selected in accordance with the rules of the American Arbitration Association. The arbitration will follow the procedures and rules of the American Arbitration Association which are in effect on the date the arbitration is filed unless those procedures and rules are inconsistent with these Terms and Conditions of Sale, in which case these Terms and Conditions of Sale will prevail. Those procedures and rules may limit the discovery available to you or us. The arbitrator will take reasonable steps to protect your customer account information and other confidential information if requested to do so by you or Prodigy. Each party to the arbitration will bear the expense of that party's attorneys, experts, and witnesses, and other expenses, regardless of which party prevails, but a party may recover any or all expenses from another party if the arbitrator, applying applicable law, so determines. Class Action Waiver
